SENIOR SCHOOL SCHOLARSHIPS

Award Conditions

The Award is made to a student who:

- 1. Has demonstrated academic achievement over years nine and ten.
- 2. Has demonstrated interest and consistent ability in a given discipline in the junior school.
- 3. Has demonstrated involvement in local and school activities over years nine and ten.
- 4. Expresses the vision of a career path in the definition of the scholarship.

Conditions

- 1. The actual value of the Award rests with the school. Award funds are to be distributed as follows.
 - O Exactly half the funds are released during Terms 1 − 3 of Year 11 and from Term 4 onwards of Year 12.
 - O Funds will be released on receipt of a decent copy of an acknowledgement letter (Year 11), or a progress letter (Year 12) addressed to your benefactor at the beginning of the school year.
 - O If there is a balance of funds at the end of the Preliminary school year this amount will be carried forward into the HSC school year.
 - O This structure dictates that you need to plan well for payment of commitments, such as Texts, Fees, Tuition, equipment related to subjects, computers and related resources, educational excursions and programs, and uniform (excluding shoes) which means you will need to make decisions on how you distribute your scholarship funds.
- 2. The Award value for individual Senior Scholarships is not the same but varies with sponsor agreement.
- 3. The value of the Award is to be best used for Senior School related expenses.
- 4. Recipients are not able to use funds for the Senior Text Book deposit.
- 5. Purchases made will be refunded, on receipt of an Approval Notice for Scholarship Funds (with original receipt/s attached) to the School Administrative Manager, after authorization from the Principal. Each claim is a minimum of \$20.00.
- 6. The value of the Senior School Scholarship not used is retained by the school for redistribution, as necessary. This may be effected either at the end of each school year or at the end of the Senior School Scholarship Tenure.
- 7. No part of the Senior School Scholarship Award value may be taken as a cash settlement.
- 8. Failure to continue satisfactory progress may terminate the Award.
- 9. Leaving the school terminates the Award.
- 10. Regular correspondence with the Sponsor is a mandatory condition attached to this award.

Exclusions

- 1. Recipients are not able to use funds for the Senior Text Book deposit.
- 2. Recipients are not able to use funds for their Year 12 Formal ticket or Jersey.
- 3. Recipients are not able to use funds for the purchase of shoes.

Judges decision is final and no correspondence will be entered into.
